

# **2025 Microgrid Tender Announcement**

### What is the community microgrid assistance partnership?

"Through the Community Microgrid Assistance Partnership, DOE plans to work closely with rural and Tribal communities to develop microgrid technologies that will lead to more reliable, affordable energy in isolated regions," said Dr. Geri Richmond, DOE Under Secretary for Science and Innovation.

#### Are microgrids a solution to electricity grid threats?

DOE argues microgrids provide a solution to electricity grid threats, such as severe weather events and physical or cyber-attacks, via localized grids that can operate autonomously, whether disconnected from the traditional grid or supporting remote/isolated communities.

### Can remote community microgrid systems be standardized?

This project will standardize and validate the digital design of Alaskan remote community microgrid systems to bridge the gap between custom on-site engineering, vendor limited control system supply and remote community centered design; allowing remote communities to play a central role in the design and management of their own microgrid systems.

### Can microgrids improve energy resilience?

Since microgrids are not the only way to enhance energy resilience, communities may want to consider alternate resilience investment options, including hardening existing transmission and distribution systems, weatherizing power generation sources, and building additional distribution systems to provide energy supply redundancy.

#### What are microgrids & how do they work?

Microgrids provide a solution to electrical grid disruptions, such as severe weather events, via localized grids that can operate while connected to the traditional grid or "islanded," as in the case of many remote and Indigenous communities.

## What is the second round of grip funding?

Successful projects will deploy Federal funding to maximize grid infrastructure deployment at-scale and leverage private sector and non-federal public capital to advance deployment goals.
