What is the federal solar tax credit?

What is the federal solar tax credit? o The federal residential solar energy credit is a tax credit that can be claimed on federal income taxes for a percentage of the cost of a solar photovoltaic (PV) system.2 (Other types of renewable energy are also eligible for similar credits but are beyond the scope of this guidance.)

#### What is a solar sales tax exemption?

The sales tax exemption also includes all components used in solar energy systems as well as sales and energy storage costs. This helps to reduce the cost of purchasing an entire solar system that would otherwise be applied to the final transaction.

#### Can I claim a solar tax credit?

When you purchase solar equipment for your home and have tax liability, you generally can claim a solar tax creditto lower your tax bill. The Residential Clean Energy Credit is non-refundable meaning that it can offset your income tax liability dollar-for-dollar, but any excess credit won't be refunded.

When does the solar tax credit expire?

It will decrease to 26% for systems installed in 2033 and to 22% for systems installed in 2034. The tax credit expires starting in 2035unless Congress renews it. There is no maximum amount that can be claimed. Am I eligible to claim the federal solar tax credit? You might be eligible for this tax credit if you meet the following criteria:

Are there income limits on the solar tax credit?

There are no income limitson the solar tax credit, so all individual taxpayers are eligible to claim the credit on qualifying solar energy equipment investments made to their homes within the United States.

### What is the Federal residential solar energy credit?

The federal residential solar energy credit is a tax credit that can be claimed on federal income taxes for a percentage of the cost of a solar PV system paid for by the taxpayer. (Other types of renewable energy are also eligible for similar credits but are beyond the scope of this guidance.)
