Why are China's solar panels exported to Europe?

Notably, around 80 percent of China's solar panels were exported to the European market during this period (Cao and Groba, 2013), driven by the generous feed-in-tariffs provided by EU governments to accelerate the deployment of solar energy (Grau et al, 2012).

Which countries export solar panels in the EU?

The largest extra-EU export destination for wind turbines was the United Kingdom (30%), followed by the United States (18%). China (98%) was by far the largest partner for extra-EU imports of solar panels in 2023 (see Figure 5). The largest extra-EU export destinations for solar panels were Switzerland (31%) and the United Kingdom (25%).

Why did the EU import value of solar panels decrease in 2022?

The EU import value of solar panels decreased by 12% between 2022 and 2023 (see Figure 2), due to a drop in prices, even though the quantity imported slightly increased by +5%. During the same period the value of EU imports of liquid biofuels decreased by -22% while the quantity fell slightly by 2%.

Why should the EU support domestic solar panels?

Are solar panels a risk to the EU?

The EU is fully dependent on China for solar panels and at least two conventional risks are associated with this. The first is the economic risk that China might in the future make use of its predominant position in global solar PV manufacturing to distort the market and artificially obtain additional economic rents.

Will Europe become a major solar-PV market?

Germany alone aims to install 215 GW by 2030,adding 160 GW of new capacity on top of the current 58 GW,almost scaling the market by a factor of four. 2 With these ambitions in place,Europe would maintain its position as one of the major solar-PV markets in the world,alongside China,India,and the United States.
