

Can I take photos of receipts at supermarket lockers

Can a store ask for a receipt if you don't show it?

The staff at any store, including big-box establishments, can ask to see your receipt as you exit. Although in most cases, you'll probably acquiesce and hand the receipt over, you might wonder whether the store could do anything if you refused to show it. The answer is generally no, but it depends on the situation.

Can a receipt checker prevent you from leaving a store?

If store personnel, including a receipt checker, prevents you from leaving when you have the right to do so, you could have a legal claim for "false imprisonment." False imprisonment occurs when you are: held without legal justification. Suppose that store personnel asked you to show a receipt, and you refused.

Should you take pictures at a grocery store?

Obviously stores don't want you taking photos of prices or creative displays for competitors' benefit or maybe spilled milk on the floor that would give them a bad reputation (even though it just occurred). Their "no pictures policy" makes sense.

Is it legal to take a photo on a store's property?

Yes and yes. Technically, it is **LEGAL** to take those photos in that it is not illegal to take them. That said, the owner of property can set whatever rules they want to control the use of their property. In other words, you have no **RIGHT** to be on that store's property, so if you want to be on their property, you have to follow their rules.

Can a store ask you not to take photos?

If you don't want to follow their rules, don't visit that store. It is private property. So, yes, store staff can demand that you not take photos. I agree with counselor Harrington. By entering the store you implicitly agree to their rules, much as the manager would if he or she entered your house. Nothing to do with copyrights.

Can a store detain you for not showing a receipt?

If an employee prevented you from leaving, you might have a false imprisonment claim. False imprisonment is both a civil violation and a crime. Store personnel should know that, in most circumstances, they can't detain you for failing to show a receipt unless you're at a membership store.
