Can a rooftop solar PV system be installed on a building?

The vast majority of rooftop solar PV systems are installed on existing structures. Even though very few of these buildings were constructed specifically for installing solar equipment, many of them are well suited for PV systems.

Do I need a building permit for a solar PV system?

Some electric utilities may require that the solar project be reviewed before the local jurisdiction issues a building permit. Pursuing utility approval early in the permit process enables the solar PV system to become operational as soon as possible.

Do solar PV installations need local government approval?

All solar PV installations need the local utility's approval to link into the electricity grid, a process commonly referred to as "interconnection." This interconnection approval must be granted before a solar PV installation is allowed to operate and is completely separate from local government approval for the solar installation.

What if a roof is not covered by solar PV panels?

Roof surfaces not covered by solar PV panels shall be designed for the roof live load(CBC Section 1607). The building official may determine that live load need not be considered for solar PV panels and associated supporting members that are built on grade.

Adding solar energy storage or other energy-efficiency measures to the home can reduce the total required capacity of the solar panel system. If your clients add solar storage capacity, they may qualify for rebates ...
