How do I pay for utilities & services through WeChat?

You can pay for utilities and services directly through WeChat by navigating to the "Bills" section of the Wallet menu. Keep track of your spending and transfers by regularly checking your WeChat wallet's transaction history.

Can foreigners use WeChat Pay?

Foreigners can link international credit cards (Visa, MasterCard) to WeChat Pay. Input your card details, and ensure your card supports international transactions. Verification might involve a small transaction to confirm the card's validity. If you have a Chinese bank account, you can directly top up your WeChat wallet from this account.

Do all stores accept WeChat Pay?

Not all stores accept WeChat Pay. Do keep an eye out for any in-store WeChat Pay signage or enquire with the staff directly before making a payment! You can also use Alipay as an alternative payment method - here's our Alipay for foreigners guide!

Does WeChat Pay work in China?

I've been using a US credit card with Wechat pay in Shanghai and Beijing with no issues. Just make sure your credit card does not have international fees and you inform your credit card company you will be using it in China. Alipay also works with an international credit card but sometimes it will use my balance instead of the card.

Do people pay for electricity through AliPay or WeChat?

When I left China, I'd heard of people paying for their electricity through Alipay, but I never tried it. Both WeChat and Alipay make it easy for people to pay their utilities. WeChat was how I paid for my water and internet. My gas card was more complicated.

Does WeChat Pay charge a transaction fee?

In terms of fees, WeChat Pay charges a 3% transaction fee for purchases above RMB 200 (~\$37). However, for smaller purchases below RMB 200, there are no transaction fees. Q: Does WeChat Pay have any spending limitations?
