Today's legal actions are the result of the Attorney General's Consumer Protection Division investigations revealing the companies misled consumers about solar panel system installation processes, misrepresented pricing and incentives, and in some cases, caused damage to customers' property.

#### What is the Florida Attorney General's Office doing about solar panels?

The Florida Attorney General's Office is seeking to permanently enjoin both companies from making unsubstantiated or misleading claims, or engaging in any business practice that misleads consumers about solar panel systems. The actions also seek to recover refunds and other relief for consumers for harms suffered as a result of these practices.

#### Who sued vision solar?

Vision Solar was also sued by Connecticut Attorney General William Tongin March after the office received more than a dozen consumer complaints.
