Are solar panels hazardous waste?

The most common reason that solar panels would be determined to be hazardous waste is if they meet the characteristic of toxicity. Heavy metals like lead and cadmium may leach at such concentrations that waste panels would fail the toxicity characteristic leaching procedure (TCLP), a test required under RCRA to determine if materials are hazardous.

#### Are solar panels a hazardous waste under RCRA?

If these metals are present in high enough quantities in the solar panels, solar panel waste could be a hazardous waste under RCRA. Some solar panels are considered hazardous waste, and some are not, even within the same model and manufacturer.

#### Are solar panels a universal waste?

EPA received a petition to add solar panels as a federal universal waste and is initiating a proposed rulemaking effort to add solar panels as a federal universal waste. Are solar panels analogous to spent circuit boards when managed under RCRA? No. Solar panels are not analogous to circuit boards.
