What happens if Jinko discontinues a PV module?

Jinko shall at its own option to deliver another type of PV Modules (different in size, color, shape, or power), either a new brand or the original one, in case that Jinko has discontinued producing the Module in question at the time of the claim.

What warranties does Jinko provide?

("Jinko") generally provides the Warranties set forth herein to the original purchaser and its permitted successors and assigns ("Customer") with respect to all solar photovoltaic modules sold by Jinko under purchase agreements signed on or after November 23, 2018 ("Modules"), subject to the terms and conditions herein ("Limited Warranty").

What is JKMxxxM-7RL3-DV warranty?

JKMxxxM-7RL3-DV (i) 2.5% in the first year; (ii) 0.5% each year thereafter until that date which is thirty (30) years following the Warranty Start Date, at which time the Actual Power Output shall be not less than 83% of the Nominal Power Output. 3.B. LIMITED POWER WARRANTY FOR
