What is a solar power purchase agreement (SPPA)?

A Solar Power Purchase Agreement (SPPA) is a financial arrangementin which a third-party developer owns, operates, and maintains the photovoltaic (PV) system, and a host customer agrees to site the system on its property and purchases the system's electric output from the solar services provider for a predetermined period.

#### Can a provider sell a photovoltaic system to a customer?

WHEREAS, Provider has offered, at his sole cost and expense, to install, maintain, own, replace, repair, and operate a photovoltaic system at one or more of the Property (ies) and to sell Solar Services (as hereafter defined) produced by the solar photovoltaic system to Customer as provided in and subject to the provisions of this Agreement.

#### What is a PV installation agreement?

The Installation Agreement is a lump-sum agreementbetween the project company, as owner of the project, and the installation contractor, the contractor that will be responsible for installing the PV system, providing the balance of plant and commissioning the plant.

What is a solar service provider (SPPA)?

With this business model, the host customer buys the services produced by the PV system rather than the PV system itself. This framework is referred to as the "solar services" model, and the developerswho offer SPPAs are known as solar services providers.

What is the scope of work for a solar facility?

Scope of Work. The Contractor shall furnish all of the materials, perform all of the solar facility installation work, and provide all documentation as described in Exhibit A - Scope of Work. Time of Completion. The work to be performed under this contract shall be commenced on or before [Start Date] and shall be completed on or before [end date].

### What is SPGA Implementation Agreement?

The Implementation Agreement is the root contractwhereby the government concessions to the project company the right to develop, build and operate the SPGA and procures the buyer to purchase the power from the project company under the PPA.
