How much does a rooftop solar system cost?

Mounting system: This is what holds rooftop solar panels in place. Costs vary depending on the type of solar installation, but it generally costs between 7 and 20 cents per watt. **Electrical wiring and hardware:** This includes the wiring, switches and circuit breakers required to connect the solar panel system to your home's electrical system.

Is financing solar panels worth it?

Financing solar panels is worth it if the loan payments are cheaper than your current utility bill. Leasing a system is cheaper upfront, but you won't get the federal tax credit. The average 5-kilowatt (kW) solar panel system is \$14,210 before considering any financial incentives.

How much do solar panels save a year?
