Do you need a permit to install solar panels?

Generally,local governments require a homeowner's solar installer/contractor to obtain a permitfor rooftop panels before they can be installed. After the PV system is installed, a professional from the local government will inspect the new array to ensure all building, electrical, and safety codes have been followed.

### Do I need an inspection before installing solar panels?

An inspection before installation is necessaryto ensure that your property's electrical system can handle the addition of solar. If you're installing a rooftop solar panel system, an engineer will also need to inspect your roof's structure to make sure it can withstand the additional weight of the solar panels and racking equipment.

### Do I need a permit to install a solar hot water system?

Before installing a solar hot-water or a solar electric-generating system, also known as photovoltaics, you must hire a Professional Engineer or Registered Architect to be sure your building's structural system can maintain the weight of the equipment. Permits are required for the installation of all building-connected solar energy systems.
