What is WeChat Pay?

WeChat Pay is a payment feature integrated into the WeChat app, allowing users to complete payments quickly and securely on their mobile phones. Before you can use the money app, you'll need to add a credit card (or a Chinese bank account if you have one) and verify your identity.

Can I use WeChat to pay a merchant?

You can use it to pay merchants such as DiDi taxis, Trip, and Air China but you cannot make transfers to individuals or send red packets. You can however use it in-store for merchants' QR codes so this is still a useful way to access WeChat's payment function.

How many banks does WeChat Pay support?

As of 2019, WeChat Pay supports a total of 408 banks (288 savings cards, 117 credit cards, and 3 foreign card organizations). Up to 10 bank cards of the same name (including credit card) can be bound to each WeChat payment account. Non-continental bank cards only support binding credit cards.
