Does EPA fund solar for all projects?

EPA will not fund individual projects through Solar for All. A Solar for All program is a program that ensures low-income households have access to residential rooftop and residential-serving community solar energy, often through providing financial support and other incentives.

What is EPA's solar for all competition?

EPA's Solar for All competition is designed to deliver the benefits of solar energy to households. Solar for All grantees can fund both residential rooftop solar projects and residential-serving community solar projects so long as the projects serve households.

Are solar panels regulated at end of life?
