Do you have to report a monthly photovoltaic account?

The subset of respondents now must report monthly accounts for about 90% of photovoltaic (PV) activity in the United States, based on 2021 data. Data collected on both the monthly and annual Form EIA-63B are protected from disclosure of individual company data. As a result of this protection, monthly data are not published in some tables.

What does 9693 mean for crystalline silicon photovoltaic (CSPV) cells?

On January 23, 2018, the President issued Presidential Proclamation 9693 under Section 201 of the Trade Act of 1974 providing for a tariff rate quota (TRQ) for Crystalline Silicon Photovoltaic (CSPV) cells; and an additional duty for modules comprised of CSPV cells, effective February 7, 2018. See 83 Federal Register 3541, January 25, 2018.
