Are solar panels a viable option?

However, some states still make installing solar panels functionally impossible by creating laws with "reasonable restrictions," such as increased taxing, energy caps, or even billing solar panel users. Combine these laws with a lack of incentive programs, and solar panels are not viable for homeowners in many states.

What happens if a solar panel is discarded?

Federal solid and hazardous waste regulations (i.e.,the RCRA requirements) apply to solar panels when they are discarded. When a solar panel reaches the end of its usable life or is otherwise discarded,it becomes solid waste. Solid waste is regulated federally under RCRA Subtitle D and through state and local government programs.

Are solar panels a hazardous waste under RCRA?

If these metals are present in high enough quantities in the solar panels, solar panel waste could be a hazardous waste under RCRA. Some solar panels are considered hazardous waste, and some are not, even within the same model and manufacturer.

Can hazardous waste solar panels be recycled?

Hazardous waste solar panels that are recycled may be able to use regulatory exclusions available under RCRA,including the transfer-based exclusion (Title 40 of the Code of Federal Regulations section 261.4 (a) (24)) in states that have adopted the 2015 or 2018 Definition of Solid Waste Rule.
