

# WTO rejects photovoltaic panels

What did the WTO panel reject?

Are China's safeguards against silicon photovoltaic cells inconsistent with WTO rules?

In reporting the news, the Bloomberg news agency said that China failed to establish that Washington's safeguards against imports of certain crystalline silicon photovoltaic cells were inconsistent with the WTO's rules on the measures. The Geneva-based body issued its findings in a report.

Can a WTO Dispute Panel defend a general safeguard action?

This is the first successful defense of a general safeguard action before a WTO dispute panel. "I welcome the WTO panel's findings rejecting China's challenges to the U.S. solar safeguard as baseless," said Ambassador Katherine Tai.

Why did China request a WTO review?

That review is ongoing. In July 2019, China requested the establishment of a WTO panel alleging that the U.S. imposition of the safeguard was inconsistent with various obligations under the General Agreement on Tariffs and Trade 1994 and the WTO Agreement on Safeguards. The Panel rejected all of China's claims.
